#### **International Credential Recognition**

A license to practice — or "classification" — is required to work as a qualified educator in regulated child care or pre-primary in Nova Scotia. Individuals apply for a classification with Classification Services, Department of Education and Early Childhood Development. International credentials are measured against the <u>Standards for Early Childhood Education Post-Secondary Programs</u>.

For those with an international credential, this is a two-step process:
